Letters from the Archives: 7TH Degree, Thursday October 1, 2009 Newington, Connectcut

REPUTATION MATTERS

Excitement from reading Dan Brown's The Lost Symbol two weeks ago lingers as a warm feeling of expectation as I approach my first view of the 7th Degree. The Valley of Hartford has a beautiful theater in Newington with dinner served in an adjacent building. I'm happy to have been here before because my mind isn't distracted by directions and distances and the awkwardness of being a stranger.

There's a large audience of thirteen or so candidates, five or six thirty-three Degree Masons, two Grand Lodge officers, and about three dozen others. Emory Meyerjack comes and sits with me. He is on the verge of his year as Master of Ashlar Aspetuck and shares my ambition to see all Scottish Rite Degrees.

Workmen file in from the rear of the auditorium. The setting on stage is of an ancient stone query supplying blocks for the Temple of Solomon. Working tools are in abundance.

Jeroboam, a false and lazy worker steals the carefully wrought key stone from Amos. Amos is blamed for the loss and is bewildered by the betrayal of his heretofore trusted friend. A Provost Judge intervenes to uncover the truth.

Jeroboam's past violations cast doubt on his claim while Amos's exemplary record stirs the judges to press each man about their conflicting claims and to seek independent means to discover the truth. Reputation matters.

In the end, Jeroboam confesses and admits jealousy, envy and hatred toward his harder working, more highly skilled friend. He pleads for mercy. Unbelievably, Amos supports his plea, for as God is merciful, so also should we be.

Coincidentally, it's just a few days now since Yom Kippur, the Day of Atonement and holiest day in the Jewish

religion when Rabbis remind their congregants of the virtue of mercy. Truth, justice, and mercy are timeless and never change. One of the arguments in favor of mercy is that a man's conscience will plague him forever. But what of men who lack conscience and feel no guilt?

Two Cents on Pike's Seventh Chapter, "Provost and Judge," in *Morals and Dogma*: Pike's chapter on the 13th Degree was mercifully short making my return to *Morals and Dogma* for the 7th a real pleasure. I enjoy his maddening digressions, challenging references, stern judgments, and determined optimism about man's potential. Immediately, I discover a plain truth which I had not recognized: jurors are judges when called upon to determine guilt or innocence. How many courtroom dramas have I seen on television and films? How many times have I been called for jury duty and not realized that had I been chosen, I would bear the burden of Solomon in company with my fellows?

Pike chooses unrelenting passages from Gregg's *Creed of Christendom* to emphasize the terrible impact of wrongdoing: "A wrong done to another is an injury done to our own Nature, an offence against our own souls, a disfiguring of the image of the Beautiful and Good. . . . The act which has debased our soul may be repented of, may be turned from; but the injury is done. . . . The commission of the wrong is an irrevocable act . . . Repentance is still as valid as ever; but it is valid to secure the Future, not to obliterate the Past." (200-201 and De Hoyos's notes 3-7) Convincingly, he makes his case that, "There must always be a wide difference between him who only ceases to do evil, and him who has always done well." (200)

But with humility and wisdom, Pike explores the varying degrees of temptation and the weight of circumstances

experienced by men when committing wrong. In his own voice he declares, "When we condemn or pity the fallen, how do we know that, tempted like him, we should not have fallen like him, as soon, and perhaps with less resistance?" (203) His conclusion resounds with Biblical authority, "On all accounts, therefore, let the true Mason never forget the solemn injunction, necessary to be observed at almost every moment of a busy life: 'Judge not, lest ye yourselves be judged: for whatsoever judgment ye measure unto others, the same in turn be measured unto you." (206) So mote it be.


